This Elementary and Secondary School Emergency Relief Expenditure Plan (ESSER III) was developed with input and/or meaningful consultation with students, and families (including families that speak languages other than English), school administrators, teachers, paraprofessional staff and other school staff. RCP provides translation and interpretation in Spanish with all communication with parents and community. We held meetings via zoom with parents and community throughout the 2020-2021 school year to provide parents and community opportunities to provide input into the LCAP and ELO. These groups included the LCAP Steering Committee, the ELAC, the SSC and the weekly Friday Parent meetings, all via Zoom. This input was used to inform the development of this ESSER Plan. Additionally surveys were done throughout the year to provide opportunities for input from the parents, staff and students. Again, this information was used to inform the development of the ESSER Plan. Since the opening of the 2020-2021 school year, we have continued to have our monthly and weekly meetings and have used their input to develop this plan. Information was also provided by staff at staff meetings, teachers at grade-level and collaboration meetings and from students via teachers and student representatives on the SSC, as well as surveys. Tribes, civil rights organizations, and advocates for underserved students, beyond the existing parent/community/staff committees, are not applicable.

All expenditures in the ESSER Plan were developed based on the input of our stakeholder groups, community, parents, staff and students.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
